### Waitsfield Water Commission PUBLIC HEARING NOTICE WATER ORDINANCE UPDATE May 11, 2017, 7:00 P.M., Waitsfield Town Office

The Waitsfield Water Commission will be hosting a public hearing on Thursday, May 11, 2017, 7:00 P.M. to present and receive public comment on a variety of amendments to the Waitsfield Community Water System Ordinance, originally adopted in May, 2011 in accordance with 24 VSA Chapter 59 and 24 VSA §3315. The ordinance applies only to those properties in the water service area of Waitsfield Village and Irasville and properties eligible for connection along the transmission route. The ordinance includes:

- General provisions
- Formation of a Water Commission
- Definitions and abbreviations
- Connection and service provisions
- Enforcement and penalty provisions
- Water Service Boundary Map
- Appendices

The document will be available for review at the Waitsfield Town Office and on-line at www.waitsfieldvt.us. 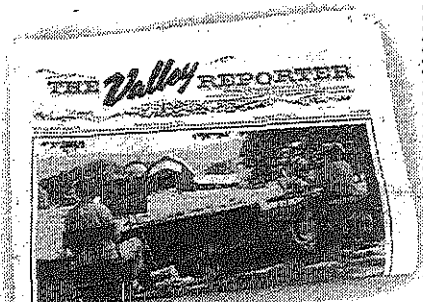
