Mr. Ketchel called the meeting to order at 7:40 pm.

Mr. Klofach began the discussion about proposed changes to Chapter 3 that involves the expansion of wildlife conservation and preservation. Members questioned whether the directives were too detailed and a possible burden on the homeowner while others also reminded the Commission that the emphasis on wildlife in the Town Plan wouldn't be there if the townspeople didn't put a value on it. When it got down to definition of terms, there was some difference of opinion and the suggestion was made to get a couple of individuals who were professionals in the wildlife "industry" to offer their knowledge and insights. Also included in Chapter 3 in reference to conservation strategies is the use of alternative/renewable energy which was discussed briefly by the members and suggested that Objective 3.7 (e) be expanded/rewritten. Chapter 8 had been reviewed and the members quickly went over some final edits.



The meeting was adjourned at 9:38 pm. The next scheduled meeting of the Planning Commission is for Monday July 12, 2010 at 7:30 pm.


